Governance

Authorization decision making process

 Federal Office for the Environment (FOEN) as authorizing entity for the Swiss Government

Coordination process:

- Across ministries: foreign affairs, economy, energy (and others, as relevant)
- Decision-making prepared on two levels:
 - Technical experts
 - Director sign-off



Authorization statement elements

- Date of authorization (date of signature of this authorization statement): 27.02.2023
- Entity authorized (to transfer): Energy Absolute Public Company Ltd, Bangkok
- III. ITMO uses authorized: ITMOs are authorized for use towards NDC, as specified in the authorization statement by the Ministry of Natural Resources and Environment of the Kingdom of Thailand (MONRE).
- IV. Definition of first transfer: The first transfer, triggering corresponding adjustments by the host Party is defined by the recognition of the occurred international transfer of an ITMO under the Implementing Agreement (Article 8).
- V. Authorized mitigation activity: "Bangkok e-bus Program" (project ID number 5002) as determined below and in the annexed Mitigation Activity Design Document (MADD). Applied standards and baseline methodologies as well as requirements for monitoring and verification, including for contributions to sustainable development, apply as specified in the MADD.
 - Total cumulative maximum amount of Mitigation Outcomes for which international transfer and use is authorized: 500'000 of t CO₂eq
- VI. Authorized crediting period: 1 October 2022 31 December 2030

- IX. The following method for corresponding adjustment will be applied by the Swiss Confederation pursuant to 2/CMA.3 paragraph 7 of the Annex (Art 6.2 guidance): trajectory approach as defined in paragraph 7.a.i for the single year target of Switzerland's NDC (minus 50 percent in 2030 compared to 1990) and 7.b for the multi-year target of Switzerland's NDC (minus 35 percent over the period 2021-30 compared to 1990)



Authorization elements can differ

Acting as the authorized entity of the Swiss Government, the Federal Office for the Environment (FOEN)¹ hereby authorizes per Article 6.3 of the *Paris Agreement* and per Article 5.1 of the Cooperation Agreement between the Swiss Confederation and the Republic of Ghana towards the Implementation of the Paris Agreement signed on 23rd November 2020 (hereafter referred to as the Cooperation Agreement) the international transfer and use of Internationally Transferred Mitigation Outcomes (ITMOs) specified in this statement. The provisions of the Cooperation Agreement apply.

- Date of authorization (date of signature of this authorization statement): 11.11.2022
- Entity authorized (to transfer): UNDP Country Office Ghana
- III. ITMO uses authorized: ITMOs are authorized for use towards NDC, other international mitigation purposes and other purposes, including the voluntary offsetting, as specified in the authorization statement by the Republic of Ghana.
- IV. Definition of first transfer: The first transfer, triggering corresponding adjustments by the host Party is defined by the recognition of the occurred international transfer of an ITMO under the Cooperation Agreement (Article 8).
- V. Authorized mitigation activity: "Promotion of climate smart agriculture practices for sustainable rice cultivation in Ghana" (project ID number 5001) as determined below and in the annexed Mitigation Activity Design Document (MADD). Applied standards and baseline methodologies as well as requirements for monitoring and verification, including for contributions to sustainable development, apply as specified in the MADD
 - Total cumulative maximum amount of Mitigation Outcomes for which international transfer and use is authorized: 1'125'655 of t CO2eq
- VI. Authorized crediting period: 1 June 2022 31 December 2030
- VII. NDC period(s) during which the Internationally Transferred Mitigation Outcomes (ITMOs) are authorized for use, as appropriate: 2021 2030

Authorization elements

- Switzerland's authorization letter covers:
 - Entity authorized
 - Maximum volume (tons of CO2e)
 - Use types (NDC, and other)
 - Crediting period
 - Time validity
 - Until 2030
 - Use within same NDC implementation period
- Accompanying information in initial report published simultaneously with authorization
 - Corresponding adjustment method, NDC relationship, tracking arrangements etc.



Next steps after authorization

- Authorization marks moment of «registration»
 - → Forward-looking promise for recognition of ITMOs under specified conditions (in the MADD)
- ITMO transfer steps:
 - (1) Verified monitoring report approved by cooperating Parties in the context of bilateral agreements
 - (2) International transfer requested by entity authorized
